- Nothing can be tacked, nailed, screwed, or otherwise attached to the columns, walls, floors, ceiling, furniture, or other property of the Market Xchange Building or Silver Lining Productions Inc.
- Storage of empty packing containers is available free of charge in an unsecured area. All containers and boxes must be labeled with the vendor's name.
- Secured storage is available between shows for a nominal fee. Contact Silver Lining for more information.

TEAR DOWN & MOVE OUT
